PUBLIC MEETING MINUTES

Roll call was as follows: Present: Mayor Jeter, Alderpersons Perkins, Robinson and Carroll, attorney Greg Jones, and Chief Carroll.

- 1) Mayor Jeter called the meeting to order@ 6:00pm.
- 2) Roll call presented above; quorum met.
- 3) Invocation led by Sam Echols.
- 4) Pledge led by Alderperson Robinson.
- 5) Mayor Jeter welcomed everyone.
- 6) No public comments on agenda items.
- 7) Motion to adopt 4/18/22 minutes as published made by Alderperson Carroll, second by Alderperson Robinson, motion carried.
- 8) Motion to adopt financial statements as presented made by Alderperson Robinson, second by Alderperson Perkins, motion carried.
- 9) Old Business:
 1. Resolution 22-03 Mayor read the Announcement of Public Meeting: Notice is hereby given that at its meeting to be held on Tuesday, May 10, 2022 at 6:00 p.m. at its regular meeting place, Municipal Complex Room #2, 138 Blue Lake Road, Forest Hill, Louisiana, the Mayor and Board of Aldermen of the Village of Forest Hill, State of Louisiana, plans to consider adopting a resolution ordering and calling an election to be held in the Village of Forest Hill, State of Louisiana, to authorize the levy of a sales and use tax therein. After discussion, motion to proceed to add sales tax to ballot was made by Alderperson Perkins, seconded by Robinson; motion carried unanimously.

 - 2) Motion to select The Town Talk as official journal for the Village of Forest Hill was made by Alderperson Robinson, second by Carroll; motion carried unanimously.
- 11) Chief Carroll presented the Police Report.
- 12) Jason Murphy presented the Engineer Report.
- 13) Motion to add item to agenda: Discuss upgrade to Stokes Lane made by Robinson; second by Carroll; motion carried. After discussion of work to be done, motion was to enter Resolution awarding award to Womack & Sons Construction for Phase 3 on Stokes Lane made by Robinson, second by Carroll, motion carried.
- 14)Greg Jones presented attorney report.

With no further business, motion to adjourn was made by Robinson second by Perkins; motion carried. Meeting was adjourned.
